Van Buren County Solid Waste Department Uncollectible Accounts Write-Off Policy and Procedures

BACKGROUND:

Van Buren County has various non-tax accounts receivable resulting from operations. Some of these receivables become uncollectible after a period of time, or an event.

PURPOSE:

To establish uniform guidelines for determining which delinquent accounts receivable should be considered a bad debt and written off. Also, to provide a fair representation of accounts receivable balances in the County's Financial Statements.

POLICIES:

Accounts receivable will be maintained in the County's Financial Statements for three calendar years from the Invoice date or date the last payment was received, whichever is later. After 90 days, the Van Buren County Attorney will attempt to collect.

An account will be written off, only after one or more of the following have occurred:

- Receivables have been listed Uncollectible due to the person being deceased.
- Approval for ALL write-offs of individual accounts is REQUIRED to be approved by the County Commission.

PROCEDURES:

The Solid Waste Director shall prepare and review and Aged Trial Balance of accounts receivable at year-end to determine if delinquent receivables meet the

requirements set forth herein, to be written off a bad debt. A report will be prepared and submitted for approval(s). At a minimum, the following information will be included in the write-off request:

- 1. Name
- 2. Invoice Date
- 3. Amount
- 4. Invoice Number
- 5. Type of service rendered

PAYMENT RECEVED AFTER WRITE-OFF:

Any payment received on an account that has been written off will be recorded as revenue for Solid Waste in the period in which it is received.

trash. Mrs. Woodlee stated, "We have had a lot of trouble with the County's litter pickup trucks, we have a new employee and the first week the trucks broke down two different times." "The Ford 2017 that was just given to us has to have a transmission, we have had it towed twice and the other truck has been towed also." Gooseneck Garage sent a quote of the removal and replacement of the transmission with a new one, 3 yr. unlimited warranty in the amount of \$5,423.65. The same vehicle has just had to have the starter and water pump replaced. The 2nd quote from a different place was to have the transmission rebuilt with a 2yr. warranty in the amount of \$4,618.30. Mrs. Woodlee explained, "We moved \$28,000.00 from the ARP money into 101 for a litter truck, no new truck is going to cost \$28,000.00." Mrs. Woodlee would like the Commission to consider putting another \$20,000.00 and purchasing a new litter Truck.

Commissioner Terry Hickey strongly recommends if the County is putting in a new transmission that it needs to be at a Transmission Shop with a warranty and he thinks we need to buy a reliable used vehicle. After much discussion on this matter, Tabitha Denney made a motion, seconded by Michael Chandler to approve to move \$50,000.00 from Fund Balance 39000 to 101-64000-708 litter trucks. (\$28,000.00 which was ARP money and the rest will be County funded)

RESOLUTION ENDORSING THE USE OF VISUAL SURVEILLANCE DEVICES TO ENHANCE LAW ENFORCEMENT IN VAN BUREN COUNTY
